In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 8.5.2009 in Civil Appeal No 887/2009, the UGC notified " Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" and compliance of the 2nd Amendment in UGC Regulations, it is compulsory for each student and his/her parent/Guardian to submit an online undertaking each academic year at either of the two designated web sites, namely www.antiragging.in and www.amanmovement.org.

As part of UGC's initiative towards reduction of compliance burden of its stakeholders, UGC has revised the procedure for students to file online Anti Ragging Affidavit.

The revised procedure is as follows:

Step 1: A student will submit his/her details on the same web sites www.antiragging.in and www.amanmovement.org as before; read and confirm that he/she and his/her parents/Guardians have read and understood the regulations on curbing the menace of ragging. He/she will confirm & agree that he/she will not engage in ragging in any form. (Step 1 is the same like before).

Step 2 : The student will receive an e-mail with his/her registration number and a web link. The student wil forward the link to the e-mail of the Nodal officer in his/her university/college. (Please note that the student will not receive pdf affidavits and he/she is not required to print & sign it as used to be the case earlier).

Step 3: The Nodal Officer in the university/college can click on the link of any forwarded e mails that he/she will receive from any student of his/her college to get the list of those students who have submitted Anti Ragging Affidavits/Undertakings in his/her college. The list will be updated every 24 hours.

Note : All students are required to submit Anti Ragging Undertaking Reference No at the time of admission to the college.

Teaching Aids

Centre of Excellence

This skilling Centre occupies pride of place as a unique hub of dental training at the national level. The Center of Excellence is involved in imparting continuing dental education using advanced simulation techniques, haptic technology and other latest technological advances. Best training options and treatment planning guidance will be provided by highly trained and experienced staff. A few of the state of the art facilities on offer for training will be Cone Beam Computed Tomography (CBCT), guided implant surgery training and lasers in dentistry.

Dental Education Unit (DEU)

Dental Education Unit functions to enhance the teaching qualities of the faculty members to ensure content delivery by implementing curriculum in an organized manner to the students and also to improve the learning abilities of the students. DEU focuses on developing an educational system that fosters excellence and moulds a teacher into a competent dental educator by ensuring continuous quality improvement in teaching, learning, assessment and evaluation. DEU has started promoting interdisciplinary multi-modular, outcome based education in dental sciences. There will be introduction of integrated courses, CAT (Critical appraisal Teaching), and early exposure to clinical dentistry to the BDS students. DEU will facilitate collaborative research with allied health professions. DEU helps faculty to stay updated with current trends in dental education through educational workshops and conferences. DEU organizes orientation and induction programs to the newly appointed teachers about modern teaching, assessment and evaluation techniques and certifies them to be trained teachers in Dental Sciences. DEU also organizes refresher courses and faculty development programs for all faculty members.

Behavioral Sciences Unit

Education at ACDS involves training in language and communication skills. Students are honed by constant exposure to Behavioral Science education by subject experts. This focus on behavior and communication braces the ACDS student to adapt to situational needs and helps in gaining vital life skills necessary for successful professional life.

Library

Our ACDS Central Library is well equipped to support & encourage scholarly communications & professional development. Presently our library has around 3447 books, 33 international journals with back volumes, e- consortium for students & staffs. Free online journals are made available to our students any time. Education at ACDS

Education at ACDS is aimed at inculcating the following signature attributes for a Dental Graduate from ACDS:-

The teaching-learning methods practiced at ACDS are rooted in the current trends of dental education practiced worldwide. The focus of education is on transformative learning so that dental graduates from ACDS emerge as accomplished dentists equipped to provide comprehensive dental care. They would have ingrained all the attributes necessary to perform in their role as a dental surgeon with exemplary success. ACDS has pioneered a hybrid teaching methodology of inculcating outcome-based education within the framework of the statutory curriculum. ACDS has set clearly defined program objectives that the graduating student would have attained at graduation. Through a mapping of the program and course objectives at every year of study, a student is gradually led to achieving increasing levels of competence. Teaching schedules and lesson formats are in place to deliver a structured learning experience.

The Dental curriculum as set down by the Dental Council of India (DCI) and the KNR University of Health Sciences, Warangal, Telangana, recommends that the dental graduate fulfill competencies. These include general skills, diagnosis, treatment planning, communication, community resources and practice management. The implementation of the curriculum at ACDS focuses on empowering the graduate to fulfill these competencies and practice evidence-based dentistry. The dental student is made industry ready on graduation by incorporating the newer learner-centric methods of education technology such as Problem based learning (PBL), Clinical Decision Making (CDM), Critically Appraised Topics (CAT) and community outreach programs.

Co-curricular activities will be pivotal in providing a pragmatic educational system that will allow application of robust scientific and humanistic values to clinical practice. The educational approach at ACDS is designed to provide training that will enhance the cognitive, affective, and psychomotor domains and thus provide integrated and holistic development.

ACDS encourages blended learning with the optimal use of digital learning resources. ACDS implements Continuous Comprehensive Assessment, which includes an assessment of varied facets of a dental professional. Self-assessment at all levels is encouraged and incorporated for continual improvement.

Every student who enters the premises of the Army College of Dental Sciences is an oral health leader in the making. The Institution strives to achieve this goal as guided by its vision and mission statements as well as by staunchly adhering to the norms as stipulated by the statutory bodies. The Institution has adopted evidence-based methods to define and implement learning outcomes, where teaching, learning, and assessment process are mapped to achieve the desired graduates attribute through Outcome-Based Education. The Institution strongly believes that these methods will help metamorphose a student into a competent oral health professional that will set the stage for continual growth.

Competencies encompass Knowledge, Skills and Abilities (KSAs) in addition to other personal characteristics such as values, initiative, and motivation that contribute to successful individual and organizational performance.

The core competency of Army College of Dental Sciences, Secunderabad has been formulated based on the three-circle model for specifying learning outcomes in Dentistry namely:-

- (a) Technical intelligence (What the doctor can do).
- (b) Intellectual, emotional, analytical, and creative intelligence (How the doctor approaches their practice).
- (c) Personal intelligence (The doctor as a professional).

THE INDIVIDUAL ATTRIBUTES:

Professionalism:

This attribute covers personal values, attitudes, and behaviors. On graduation a dental student will be able to demonstrate appropriate caring behavior towards patients and respect professional boundaries between themselves and patients, patients' families and members of the community. They will recognize professional and individual scopes of practice and provide culturally safe and culturally competent practice that includes recognition of the distinct needs of the population.

Scientific, Clinical, Applied and Integrated Knowledge

A NAAC ACCREDITED GRADE 'A'

The graduated student will be able to diagnose diseases and abnormalities of the oral cavity and head/neck region. Obtain and assess information relative to systemic health of patients, initiating consultations and referrals to other health care professionals as appropriate. Develop a comprehensive treatment and /or referral plan, based on current oral disease risk analyses' and standards-of-care strategies.

Communication Skill, Interpersonal Skill and Leadership Quality

Apply inter personal and communication skills to effectively care for diverse populations of patients and collaborate with other members of the healthcare team and engage in mentor/mentee activities and leadership within a health care team.

Critical Thinking and Clinical Decision Making

Integrate and synthesize information to advance knowledge and skills through critical evaluation of biomedical literature and the application of new science. On graduation, a dentist must be competent in decision making, clinical reasoning and judgment to develop a differential, provisional or definitive diagnosis by interpreting and correlating findings from the history, clinical and radiographic examination, and other diagnostic tests, considering the social and cultural background of the individual. These attributes also help to sharpen the research skills of the student.

Clinical Expertise

Provide treatment and/or referrals as appropriate with the goal of achieving physiologic form, oral function, and health. The graduating dentist must be competent to prevent and manage the majority of medical and dental emergencies and also to identify and promptly refer dental or medical emergencies, which are beyond their scope of management.

Social Responsibility

Realize their role as community oral health leaders and demonstrate their ability to function in community-based disease prevention and health promotion activities.

Practice Management

Identify the business principles and programs used in the administration of a dental practice while complying with all regulations, policies and protocols that relate to health, safety, and the law. Apply principles of risk management, quality improvement, infection control and radiation safety to patient care

Ethics and Jurisprudence

Demonstrate an understanding of the concepts of professional ethics, health care principles and a familiarity with the DCI norms for Professional Conduct.

Pain Management

Utilize pharmacological therapies and behavioral techniques to prevent or manage pain and anxiety.

Oral Health Education

Educate patients, parents and/or care givers with individualized instructions for improving nutrition and maintaining good oral health, monitoring and re-evaluating.

COURSE AND SEATS

The College offers the course leading to award of degree of '**Master of Dental Surgery**' in (1) Prosthodontics and Crown & Bridge (2) Conservative Dentistry & Endodontics (3) Periodontology (4) Pedodontics and Preventive Dentistry (5) Orthodontics & Dentofacial Orthopedics (6) Oral & Maxillofacial Surgery by KNR University of Health Sciences, Warangal, Telangana.

The duration of the course is three years of active study. Number of seats for the current academic year is fifteen. Distribution of seats is asunder:-

(i)	Prosthodontics and Crown & Bridge	-	03 (Three)
(ii)	Conservative Dentistry & Endodontics	-	03 (Three)
(iii)	Periodontology	-	03 (Three)

Note : Out of 15 seats in MDS course, 01 x seat each is reserved for the wards of Indian Air Force and Indian Navy through PG NEET rank 2025 (**seats for Indian Air Force and Indian Navy subject to amendment in G.O**) and three seats are reserved for the students of Telangana Domicile (Competent Authority Quota - Category A) on rotation.

A candidate admitted into the MDS course shall pass the examination within 4 years from the date of completion of the course. If he/she fails to pass the examination within the period specified above, he/she shall not be permitted to appear for the examination thereafter and qualify for the award of MDS degree.

IMPORTANT NOTICE FOR ADMISSION

► The admission will be strictly on PG NEET merit ranking, based on marks obtained in NEET PG 2025.

► Kaloji Narayana Rao University of Health Sciences (KNR UHS) will issue two separate notifications for Registration in their Web site.

- **Competent Authority Quota** First notification for admission in MDS course will be notified for Competent Authority Quota (Telangana Govt seats) to the civilian/domiciled students of Telangana state.

- **Management Quota Seats** Second notification for Admission in MDS Course (Management Quota Seats for Private Non-Aided Non-Minority & Minority Colleges and ACDS) is generally issued after the last date of registration for Govt. Seats (Competent Authority Quota).

- Candidates desiring admission under Army/Air Force/Navy Quota in ACDS should register for Management Quota Seats in ACDS.
- ▶ Candidates have to register online in KNR UHS website (www.knruhs.in) by paying required Registration Fee for attending the Counselling Session for admission to ACDS under Category B Management seats.
- ▶ After successful Registration, the candidate will be issued online Acknowledgement Form with Registration Number.
- ▶ All candidates who receive Registration Number from KNR UHS should forward the following scanned copy of following documents **online** to ACDS academics@acds.edu.in:-
 - (a) Registration Acknowledgment Sheet
 - (b) NEET PG Rank Card
 - (c) Certificate 1 to 3 & 5 to 8 as applicable only (as in Prospectus)
 - (d) Alternate E mail id & two Contact Mobile numbers with names(preferably one of the Candidate and second of one parent)
- ▶ This information will assist ACDS in reminding the candidates about the dates of counselling issued by KNR UHS. However, it is the responsibility of candidates to continuously check KNR UHS website for counseling dates.
- ▶ KNR UHS prepares a University merit list as per NEET rank for those who have successfully registered online in KNRUHS website. Dates for counselling and certificate verification is announced by KNR UHS in their website generally by end Feb/ early March.
- ▶ Candidates who attend counselling are selected for various MDS specialties by KNR UHS selection Board and issued Provisional Admission Order. Prior to Counselling by the KNR UHS team, each candidate will be referred to the ACDS Help Desk located in the Counselling Centre for verification of eligibility for admission under Army Quota.

ADMISSION POLICY

Admission to the first year of the MDS degree course at the Army College of Dental Sciences, Secunderabad will be based on merit in NEET PG-2025 through Counselling conducted by Kaloji Narayana Rao University of Health Sciences, Warangal (Telangana). ACDS has got a seat sharing matrix as per the Govt. of Telangana and the same will be implemented as per the guidelines of Govt. of Telangana/KNRUHS.

Candidates will be initially granted PROVISIONAL admission by KNR UHS, which will be considered final on approval of eligibility by the University.

The College Management reserves its right to deny admission to any student in the event the admission is found to be irregular or violating any rules and/or regulations framed under any statute or statutes.

ELIGIBILITY CRITERIA

Eligibility For Admission to ACDS. Admission to ACDS is for dependent children of eligible serving Army Personnel, eligible ex- Army personnel and wards of war widows/widows of Army. The children of following categories of Army personnel are eligible and they are required to submit the relevant certificates as given against the category applicable to them as proof of their eligibility for admission to ACDS along with the application form:-

- (a) The applicants must fall in one of the following categories:-
- (i) Children of serving Army, Air Force and Navy personnel with minimum 10 years continuous service in the Army (**Submit Certificate No.1**).
 - (ii) Children of ex- Army, Air Force and Navy personnel granted /awarded regular pension, liberalized family pension, family pension or disability pension at the time of their superannuation, demise, discharge, release medical board/invalided medical board. This includes wards of recruits medically boarded and granted disability pension (**Submit Certificate No.1**).
 - (iii) Children of ex-Army, Air Force and Navy personnel who have taken discharge or released after ten years of service (**Submit Certificate No.1**).
- (b) **Adopted/Step Children and Children of Remarried Widows**
- (i) Adopted Child of Army, Air Force & Navy personnel if adopted at least five years prior to seeking admission (**Submit Certificate No.2**).
 - (ii) Step Children are eligible provided they are born from a wedding where at least one parent belonged to the Army who is otherwise eligible. (**Submit Certificate No.2**)
- (c) **Eligibility Criteria in Special Cases**
- (i) **Eligibility Criteria for wards of Ex Army Medical Corps Officers/ Army Dental Corps Officers presently serving with Indian Navy or Indian Air Force (IN/IAF).** Wards of only those ex-Army Medical Corps officers/Army Dental Corps officers presently serving with Indian Navy or Indian Air Force who have served with the Army for at least 10 years (**Submit Certificate No.3**).
 - (ii) **Eligibility Criteria for Children of APS/MNS/TA Personnel** (**Submit Certificate No.3**)
 - (aa) Children of APS Personnel classified as ex-servicemen as per Govt. of India, Ministry of Defence letter No 9 (52)/88D (Res) dated 19 Jul 1989.

(ab) Children of those APS personnel who are on deputation and who have put in 10 years of service in the Army.

(ac) Children of APS personnel, who are directly recruited into APS who have completed 10 years of service and of those who as per their terms and conditions of service, retired from APS without reversion to P&T Department after completing their minimum pensionable service of which 10 years was in the Army.

(ad) Children of only those members of MNS who have 10 years' service as regular members of MNS or are in receipt of pension from the Army.

(ae) Children of only those TA Personnel who have completed 10 years of embodied service.

Note-I (Additional Instruction For Candidates Seeking Admission In ACDS)

It is the responsibility of the candidates to ascertain whether they possess the Requisite qualifications for admission. Having been called for counseling does not mean approval of eligibility. Final eligibility for admission will be decided by ACDS and KNRUHS at the time of counseling and also later during the scrutiny of Documents by KNR University and ACDS. If a candidate is found to be ineligible at any time Before or after the commencement of course, the college reserves the right to Cancel his/her candidature without any refund of the fees/charges paid.

Note - II

(1) The Management reserves the right to include any other Eligibility criteria from time to time in addition to, as stated in item (a) to (c) above.

(2) Mid course withdrawal will be permitted only after payment of full three years of tuition fee and Miscellaneous fee.

Note – III

After qualifying in PG NEET the candidate has to refer to the KNR UHS(website www.knruhs.in) for online registration for counselling. The college management will not give any individual intimation for the same.

Physical Fitness. The candidate should be certified by MH/Authorized Medical Attendant to be in a state of good physical and mental health to pursue the course. A certificate to this effect on the enclosed form (Certificate No. 4) is required to be submitted by the candidate at the time of counseling.

Educational Qualifications. No candidate shall be allowed to be admitted to the Dental Curriculum of Master of Dental Surgery (MDS) course until he/ she has passed qualifying examination asunder:-

- (a) The applicant for admission to the Post Graduate Degree in Dental Surgery must have a B.D.S. degree (Bachelor of Dental Surgery) of a University established or incorporated by or under a Central Act or a State Act or an equivalent qualification recognized by the Dental Council of India and must have permanent registration with any State Dental Council. The period of one year experience/ internship shall be calculated as on 31-03-2025.
- (b) The candidate shall produce a certificate of Internship from the date of registration with any State Dental Council, from an Institution.
- (c) The college from where the candidate has passed BDS must be a recognized college by the Dental Council of India.
- (d) The students who are already admitted and studying MDS course are not eligible to appear for MDS admissions until they complete the course or discontinue the course by remitting the bond amount and stipend taken upto the date before submitting the Application Form and such candidates shall enclose the discontinuance certificate issued by the Principal to that effect alongwith the Application Form in the Proforma appended to the Application Form as Annexure I

Ensuring Eligibility. Ensuring that a candidate fulfills all conditions/qualifications for eligibility in the MDS Course is the responsibility of the candidate. The eligibility of the candidate will be verified by the ACDS and KNR UHS at the time of admission and also later during the scrutiny of documents by Kaloji Narayana Rao University of Health Sciences. If a candidate is found to be ineligible at any stage during the entire process, the College reserves the right to cancel his/her candidature.

Note : - It is the responsibility of the candidates to ascertain whether they possess the requisite eligibility & qualifications for admission. Being called for counseling does not necessarily mean acceptance of eligibility. Final eligibility for admission will be decided by ACDS & KNR UHS.

ADMISSION PROCESS

The admission will be strictly on PG NEET merit ranking, based on marks obtained in NEET PG-2025. Kaloji Narayana Rao University of Health Sciences (KNR UHS) will issue two separate notifications for Registration in their Web site.

- ▶ **Competent Authority Quota Seats.** First notification will be for the Competent Authority Quota (Telangana Govt. seats) for the students of Telangana State domiciled) in MDS course. Army/Air Force/Navy Candidates must not (MUST NOT) register themselves under Competent Authority Quota as it is only for the Telangana State Civilians/domiciled students. If you register under this quota you are automatically debarred from registering for the seats reserved for wards of Army/Air Force/ Navy under Management Quota.

- **Management Quota Seats.** Thereafter, notification for admission into MDS Course under Management Quota i.e., for wards of Army, Air Force and Navy (serving & retired) personnel in ACDS and also for other Colleges in Management Quota of Private Non Aided, Non-Minority & Minority Colleges is generally issued after the last date of registration for Competent Authority Quota. Candidates desiring admission under Army/Air Force/Navy Quota in ACDS should register for Management Quota Seats in ACDS.

Candidates have to register online in KNR UHS website (www.knruhs.in) by paying required Registration Fee for attending the Counselling Session for admission to ACDS under Category B Management seats.

After successful Registration, the candidate will be issued online acknowledgement Form with Registration Number.

This information will assist ACDS in reminding the candidates about the dates of counselling issued by KNR UHS. However, it is the responsibility of candidates to continuously check KNR UHS website for counseling dates.

KNR UHS prepares a University merit list as per NEET rank for those who have successfully registered online in KNRUHS website. Dates for counselling and certificate verification is announced by KNR UHS in their website generally by end Feb/ early March.

Candidates who attend counselling are selected for various MDS specialties by KNR UHS selection Board and issued Provisional Admission Order. Prior to Counselling by the KNR UHS team, each candidate will be referred to the ACDS Help Desk located in the Counselling Centre for verification of eligibility for admission under Army Quota.

Provisional Admission. All admissions made by ACDS are provisional. An admission will be considered final only when the eligibility criteria are met and the admission of the candidate to the course is confirmed by the University. The rules and regulations of KNR University of Health Sciences, Warangal, shall apply to all admissions.

FEES AND REFUNDS

FEES

The fees indicated below is for the first year only. The college being a private, unaided, nonminority institution shall be entitled to vary the fees from time to time and year to year, and the fee structure from year to year shall be binding on students seeking admission to the first year of three years MDS course:-

(d) **Stipend**. An amount of Rs 2500/- pm is paid every month to students as stipend during their period of internship.

(e) Second & Third Year - Will be notified before the commencement of next academic year.

Mode of Payment

(a) Complete payment of **Rs 6,20,000/-** as one time payment. Payments must be made through following demand drafts and must be produced at the time of KNR UHS counselling for admission into ACDS:-

(i) College Fee and Refundable Security deposit **Rs 5,80,000/-** DD to be prepared in favour of Army College of Dental Sciences (Main A/c) payable at SECUNDERABAD / HYDERABAD (OR) can be paid through NEFT/RTGS at the time of admission also.

(ii) Hostel Fee **Rs 40,000/-** DD to be prepared in favour of Army College of Dental Sciences (Hostel/Mess A/c) payable at SECUNDERABAD / HYDERABAD OR can be paid through NEFT/RTGS at the time of admission also.

(b) In addition to the above, fee for the following charges have to be paid by the students on yearly basis:-

(i) **Messing Charges**. The students Mess is run by a Mess Committee formed by students amongst themselves. Monthly messing is **Rs 4200/- (Rs 140/- per day)** or actual as worked out by the Mess Committee. Payment for one year (**Rs 50,400/-**) has to be made in advance at the time of admission as well as every year.

(ii) **Gymnasium**. Gymnasium has been installed in the college campus for students. Gym charges for Rs 600/- (i.e. Rs 50/- per month) is charged for its maint. The same will be paid in advance separately at the time of admission as well as every year.

(iii) **AWES Insurance**. All students studying in AWES Colleges have been insured centrally by HQ AWES. The AWES Insurance premium for Rs 130/- per year (Rs 390/- for three years) required to be paid in advance by the candidate.

(iv) University Fee is required to be paid to KNR UHS at the time counselling, if the candidate selected for allotment of Provisional Admission order. University fee amount and mode of payment will be available in KNR UHS website. Hence, candidate has to prepare separate demand draft as specified in KNR UHS website.

LEGAL JURISDICTION

Any dispute regarding the terms and conditions of admission, conduct of admission, course, fees, examination, attendance, pass marks, valuation of papers etc., concerning the Army College of Dental Sciences, Secunderabad shall be subject to the jurisdiction of the courts situated at Medchal-Malkajgiri District, Telangana state only.

APPEAL

Any student aggrieved by any order or orders passed by any authority or authorities of Army College of Dental Sciences shall be entitled to prefer an appeal before the Managing Committee represented by the Member Secretary and Registrar within a period of 30 days from the date of any such order and the Member Secretary shall place the appeal before the Managing Committee for passing appropriate orders. The Managing Committee presided by the Chairman may provide the right of hearing to the student or the parent and pass appropriate orders in the form of a resolution and communicate the decision of the Managing Committee/ Appellate Authority. Unless and until the remedy of appeal is availed by the student/parent, the arbitration clause cannot be invoked. The Appellate Authority or Managing Committee shall have the jurisdiction to entertain appeals concerning any grievance of the student connected with payment of fees, disciplinary action taken by the college, punishment imposed in case of malpractice or any act of misconduct, attendance, pass marks, valuation of papers etc. Wherever the matter concerns the interpretation of rules, regulations, ordinances of KNR University of Health Sciences or Telangana Universities Act, 1991 the Managing Committee/Appellate Authority shall have the right to direct the student(s)/parent(s) to KNR University of Health Sciences or any other authority or authorities for the relief prayed for. 
