In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 8.5.2009 in Civil Appeal No 887/2009, the UGC notified " Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" and compliance of the 2<sup>nd</sup> Amendment in UGC Regulations, it is compulsory for each student and his/her parent/Guardian to submit an online undertaking each academic year at either of the two designated web sites, namely [www.antiragging.in](http://www.antiragging.in) and [www.amanmovement.org](http://www.amanmovement.org).

As part of UGC's initiative towards reduction of compliance burden of its stakeholders, UGC has revised the procedure for students to file online Anti Ragging Affidavit.

The revised procedure is as follows:

**Step 1:** A student will submit his/her details on the same web sites [www.antiragging.in](http://www.antiragging.in) and [www.amanmovement.org](http://www.amanmovement.org) as before; read and confirm that he/se and his/her parents/Guardians have read and understood the regulations on curbing the menace of ragging. He/she will confirm & agree that he/she will not engage in ragging in any form. (Step 1 is the same like before).

**Step 2 :** The student will receive an E MAIL with his/her registration number and a web link. The student will forward the link to the E mail of the Nodal officer in his/her university/college. (Please note that the student will not receive pdf affidavits and he/she is not required to print & sign it as used to be the case earlier).

#### **Teaching Aids**

All classrooms are Information and Communication Technology (ICT) enabled. The classrooms are fitted with LCD Projectors, TV, OHP facilities and audio system.

#### **Centre of Excellence**

The Centre of Excellence at ACDS is the first of its kind in India and is optimally used for Faculty Development Programs. This skilling Centre occupies pride of place as a unique hub of dental training at the national level. The Center of Excellence is involved in imparting continuing dental education using advanced simulation techniques, haptic technology and other latest technological advances. The Centre of Excellence will provide a platform for up-skilling and re-skilling for dentists within and outside the Institution. Best training options and treatment planning guidance will be provided by highly trained and experienced staff. A few of the state of the art facilities on offer for training will be Cone Beam Computed Tomography (CBCT), guided implant surgery training and lasers in dentistry.

### **Dental Education Unit (DEU)**

Dental Education Unit functions to enhance the teaching qualities of the faculty members to ensure content delivery by implementing curriculum in an organized manner to the students and also to improve the learning abilities of the students. DEU focuses on developing an educational system that fosters excellence and moulds a teacher into a competent dental educator by ensuring continuous quality improvement in teaching, learning, assessment and evaluation. DEU has started promoting interdisciplinary multi-modular, outcome based education in dental sciences. There will be introduction of integrated courses, CAT (Critical appraisal Teaching), and early exposure to clinical dentistry to the BDS students. DEU will facilitate collaborative research with allied health professions. DEU helps faculty to stay updated with current trends in dental education through educational workshops and conferences. DEU organizes orientation and induction programs to the newly appointed teachers about modern teaching, assessment and evaluation techniques and certifies them to be trained teachers in Dental Sciences. DEU also organizes refresher courses and faculty development programs for all faculty members.

### **Behavioral Sciences Unit**

Education at ACDS involves training in language and communication skills. Students are honed by constant exposure to Behavioral science education by subject experts. This focus on behavior and communication braces the ACDS student to adapt to situational needs and helps in gaining vital life skills necessary for successful professional life.

### **Library**

Our ACDS Central Library is well equipped to support & encourage scholarly communications & professional development. Presently our library has around 4500 books, 24 international journals with back volumes, e- consortium for students & staffs. Free online journals are made available to our students any time. ### **Education at ACDS**

The teaching-learning methods practiced at ACDS are rooted in the current trends of dental education practiced worldwide. The focus of education is on transformative learning so that dental graduates from ACDS emerge as accomplished dentists equipped to provide comprehensive dental care. They would have ingrained all the attributes necessary to perform in their role as a dental surgeon with exemplary success. ACDS has pioneered a hybrid teaching methodology of inculcating outcome-based education within the framework of the statutory curriculum. ACDS has set clearly defined program objectives that the graduating student would have attained at graduation. Through a mapping of the program and course objectives at every year of study, a student is gradually led to achieving increasing levels of competence. Teaching schedules and lesson formats are in place to deliver a structured learning experience.

The Dental curriculum as set down by the Dental Council of India (DCI) and the KNR University of Health Sciences, Warangal, Telangana, recommends that the dental graduate fulfill competencies. These include general skills, diagnosis, treatment planning, communication, community resources and practice management. The implementation of the curriculum at ACDS focuses on empowering the graduate to fulfill these competencies and practice evidence-based dentistry. The dental student is made industry ready on graduation by incorporating the newer learner-centric methods of education technology such as Problem based learning (PBL), Clinical Decision Making (CDM), Critically appraised Topics (CAT) and community outreach programs.

Co-curricular activities will be pivotal in providing a pragmatic educational system that will allow application of robust scientific and humanistic values to clinical practice. The educational approach at ACDS is designed to provide training that will enhance the cognitive, affective, and psychomotor domains and thus provide integrated and holistic development.

ACDS encourages blended learning with the optimal use of digital learning resources. ACDS implements Continuous Comprehensive Assessment, which includes an assessment of varied facets of a dental professional. Self-assessment at all levels is encouraged and incorporated for continual improvement.

Every student who enters the premises of the Army College of Dental Sciences is an oral health leader in the making. The Institution strives to achieve this goal as guided by its vision and mission statements as well as by staunchly adhering to the norms as stipulated by the statutory bodies. The Institution has adopted evidence-based methods to define and implement learning outcomes, where teaching, learning, and assessment process are mapped to achieve the desired graduates attribute through Outcome-Based Education. The Institution strongly believes that these methods will help metamorphose a student into a competent oral health professional that will set the stage for continual growth.

Competencies encompass Knowledge, Skills, and Abilities (KSAs) in addition to other personal characteristics such as values, initiative, and motivation that contribute to successful individual and organizational performance.

The core competency of Army College of Dental Sciences, Secunderabad has been formulated based on the three-circle model for specifying learning outcomes in Dentistry namely:

- a. Technical intelligence (What the doctor can do)
  - Intellectual, emotional, analytical, and creative intelligence (How the doctor approaches their practice)
  - Personal intelligence (The doctor as a professional)

## **THE INDIVIDUAL ATTRIBUTES:**

### **Professionalism:**

This attribute covers personal values, attitudes, and behaviors. On graduation a dental student will be able to demonstrate appropriate caring behavior towards patients and respect professional boundaries between themselves and patients, patients' families and members of the community. They will recognize professional and individual scopes of practice and provide culturally safe and culturally competent practice that includes recognition of the distinct needs of the population.

### **Scientific, Clinical, Applied and Integrated Knowledge**

The graduated student will be able to diagnose diseases and abnormalities of the oral cavity and head/neck region. Obtain and assess information relative to systemic health of patients, initiating consultations and referrals to other health care professionals as appropriate. Develop a comprehensive treatment and/or referral plan, based on current oral disease risk analyses' and standards-of-care strategies.

### **Communication Skill, Interpersonal Skill and Leadership Quality**

Apply interpersonal and communication skills to effectively care for diverse populations of patients and collaborate with other members of the healthcare team and engage in mentor/mentee activities and leadership within a health care team.

### **Critical Thinking and Clinical Decision Making**

Integrate and synthesize information to advance knowledge and skills through critical evaluation of biomedical literature and the application of new science. On graduation, a dentist must be competent in decision making, clinical reasoning and judgment to develop a differential, provisional or definitive diagnosis by interpreting and correlating findings from the history, clinical and radiographic examination, and other diagnostic tests, considering the social and cultural background of the individual. These attributes also help to sharpen the research skills of the student.

### **Clinical Expertise**

Provide treatment and/or referrals as appropriate with the goal of achieving physiologic form, oral function, and health. The graduating dentist must be competent to prevent and manage the majority of medical and dental emergencies and also to identify and promptly refer dental or medical emergencies, which are beyond their scope of management.

### **Social Responsibility**

Realize their role as community oral health leaders and demonstrate their ability to function in community-based disease prevention and health promotion activities.

### **Practice Management**

Identify the business principles and programs used in the administration of a dental practice while complying with all regulations, policies and protocols that relate to health, safety, and the law. Apply principles of risk management, quality improvement, infection control and radiation safety to patient care

### **Ethics and Jurisprudence**

Demonstrate an understanding of the concepts of professional ethics, health care principles and a familiarity with the DCI norms for Professional Conduct.

### **Pain Management**

Utilize pharmacological therapies and behavioral techniques to prevent or manage pain and anxiety

### **Oral Health Education**

Educate patients, parents and/or caregivers with individualized instructions for improving nutrition and maintaining good oral health, monitoring and re-evaluating

## **COURSES AND SEATS**

The College offers the course leading to award of degree of 'Bachelor of Dental Surgery' by Kaloji Narayana Rao University of Health Sciences, Warangal (Telangana). The duration of the course is four year of active study plus twelve month of Compulsory Rotatory Internship.

**IMPORTANT NOTICE FOR ADMISSION**

▶ The admission will be strictly on UG NEET merit ranking, based on marks obtained in NEET UG-2024.

▶ **ACDS has an intake of 40 students per year. Out of these 40 seats, Six seats are for Telangana State and 34 seats are for wards of serving/ retired Army personnel. The admission for all the 34 ACDS Management Quota Seats will be carried out by Kaloji Narayana Rao University of Health Sciences (KNR UHS), Warangal, Telangana only. KNR UHS will issue two separate notifications for Registration in their Web site. First notification will be for Competent Authority Quota for Six BDS seats of Telangana State. Army Candidates must not (MUST NOT) register themselves under Competent Authority Quota as it is only for Telangana State Civilians. If you register under this quota you are automatically debarred from Registering for the 34 Army seats under Management Quota. Thereafter, notification for Admission into BDS Course Management Quota i.e., for 34 seats for wards of serving & retired Army personnel in ACDS and for others in Management Quota of Private Non Aided Non-Minority & Minority Colleges is generally issued after the last date of registration for Competent Authority Quota. Candidates desiring admission under Army Quota in ACDS should register for Management Quota Seats in ACDS.**

▶ Candidates have to register online in KNR UHS website ([www.knruhs.in](http://www.knruhs.in)) by paying required Registration Fee for attending the Counselling Session for admission to ACDS for 34 seats under Category B Management seats.

▶ After successful Registration, the candidate will be automatically issued an online Acknowledgement Form with Registration Number by the University.

▶ All candidates who receive Registration Number from KNR UHS should forward the scanned copy of following documents **online** to ACDS for verification of the same from the issuing authority. ► This information will assist ACDS in informing the candidates about the dates of counselling issued by KNRUHS. However, it is the responsibility of candidates to continuously check KNR UHS website for counseling dates.

► After the date of Registration is over, KNR UHS notifies the merit list as per NEET rank for those who have successfully registered online in KNRUHS website. Dates for counselling and certificate verification will be also announced by KNR UHS in their website generally around mid Aug 2024. Most probably this year the counselling and checking of documents will be online. Therefore, it is very important for all those who are registering with KNR UHS for admission in ACDS, to forward scanned copies of their eligibility documents to ACDS immediately for verification from their issuing authority.

► Candidates who attend counselling are selected for BDS course 2024 by KNR UHS Selection Board and will be issued Provisional Admission Order along with the date of admission.

### **ADMISSION POLICY**

Admission to the first year of the BDS degree course at the Army College of Dental Sciences, Secunderabad for 34 seats is reserved for the wards of Army/retired Army personnel and remaining 06 seats reserved for KNR UHS Convener Quota for the State of Telangana. All 40 seats will be filled based on UG NEET 2024 Merit through Counseling conducted by Kaloji Narayana Rao University of Health Sciences in Hyderabad.

Candidates will be initially granted PROVISIONAL admission. Their admission will be considered final only after acceptance of eligibility by Kaloji Narayana Rao University of Health Sciences, Warangal (Telangana).

The college management reserves its right to deny admission to any student in the event the admission is found to be irregular or violating any rules and/or regulations framed under any statute or statutes.

### **ELIGIBILITY CRITERIA**

**IT IS THE RESPONSIBILITY OF THE STUDENTS TO ENSURE THAT THEY ARE ELIGIBLE FOR ADMISSION IN ALL ASPECTS**

**Eligibility For Admission To ACDS** - The admission to ACDS is for dependent children of eligible serving Army Personnel, eligible ex Army personnel and war widows of the Army. The children of following categories of Army personnel are eligible and they are required to submit the relevant certificate as given against the category applicable to them as proof of their eligibility for admission to ACDS on the day of Counselling by KNR UHS:-

(a) The applicants must fall into one of the following categories:-

(i) Children of serving Army personnel with minimum 10 years continuous service in the Army (**Submit Certificate No1**).

(ii) Children of ex Army personnel granted/awarded regular pension, liberalized family pension, family pension or disability pension at the time of their superannuation, demise, discharge, release medical board/invalided medical board. This includes wards of recruits medically boarded and granted disability pension (**Submit Certificate No1**).

(iii) Children of ex Army personnel who have taken discharge or released after ten years of service (**Submit Certificate No1**).

(b) **Adopted/Step children and children of Remarried Widows**

(i) Adopted Child of Army personnel if adopted at least five years prior to seeking admission. (**Submit Certificate No.2**).

(ii) Step Children are eligible provided they are born from a wedding where at least one parent belonged to the Army who is otherwise eligible. (**Submit Certificate No.2**)

(c) **Eligibility Criteria in Special Cases**

(i) **Eligibility Criteria for wards of Ex Army Medical Corps Officers/Army Dental Corps Officers presently serving with Indian Navy or Indian Air Force(IN/IAF).** Wards of only those ex-Army medical officers/Army Dental Corps officers presently serving with Indian Navy or Indian Air Force who have served with the Army for at least 10 years (**Submit Certificate No.3**).

(ii) **Eligibility Criteria for Children of APS/MNS/TA Personnel (Submit Certificate No.3)**

(aa) Children of APS Personnel classified as ex-servicemen as per Govt. of India, Ministry of Defence letter No 9 (52)/88D (Res) dated 19 Jul 1989.

(ab) Children of those APS personnel who are on deputation and who have put in 10 years of service in the Army.

(ac) Children of APS personnel, who are directly recruited into APS who have completed 10 years of service and of those who as per their terms and conditions of service, retired from APS without reversion to P&T Department after completing their minimum pensionable service of which 10 years was in the Army.

(ad) Children of only those members of MNS who have 10 years service as regular members of MNS or are in receipt of pension from the Army.

(ae) Children of only those TA Personnel who have completed 10 years of embodied service.

**Note: - 1) The management reserves the right to include any other eligibility Criteria from time to time in addition to the above.**

**Note: Definition of dependent children:** Children are not dependent if they attain the following :-

- (a) **Sons.** Attaining 25 years of age as on 31 Dec 2024 or employment whichever is earlier.
- (b) **Daughters.** On marriage or employment whichever is earlier.

**Physical Fitness.** The candidate should be certified by MH/Authorized Medical Attendant to be in a state of good physical and mental health to pursue the course. A certificate to this effect as per the enclosed form (Certificate No 4) is required to be submitted by the candidate at the time of admission.

**Educational Qualifications & Eligibility Criteria.** No Candidate shall be allowed to be admitted to the Dental Curriculum of first Bachelor of Dental Surgery (BDS) Course until:-

- (a) He/she shall complete the age of 17 years on or before 31st December, of the year of admission to the BDS course

- (b) He/She has qualified in NEET(UG) 2024.

- (c) He/she has passed qualifying examination as under:-

Ø The higher secondary examination or the Indian School Certificate Examination which is equivalent to 10+2 Higher Secondary Examination after a period of 12 years study, the last two years of study comprising of Physics, Chemistry, Biology(Botany, Zoology)/Bio Technology and other elective subjects with English at a level not less than the core course for English as prescribed by the NCERT after the introduction of the 10+2+3 years educational structure as recommended by the National Committee on education; Note: Where the course content is not as prescribed for 10+2 education structure of the National Committee, the candidates will have to undergo a period of one year pre-professional training before admission to ACDS.

or

(ii) The intermediate examination in science of an Indian University/Board or other recognized examining body with Physics, Chemistry and Biology/ Bio technology which shall include a practical test in these subjects and also English as a compulsory subject.

or

(iii) The pre-professional/pre-medical examination with Physics, Chemistry and Biology/ Bio technology, after passing either the higher secondary school examination, or the pre-university or an equivalent examination. The pre-professional/pre-medical examination shall include a practical test in Physics, Chemistry and Biology/Bio Technology and also English as a compulsory subject

or

(iv) The first year of the three years degree course of a recognized university, with Physics, Chemistry and Biology/ Bio Technology including a practical test in three subjects provided the examination is a "University Examination" and candidate has passed 10+2 with English at a level not less than a core course.

or



(v) B.Sc examination of an Indian University, provided that he/she has passed the B.Sc examination with not less than two of the following subjects Physics, Chemistry, Biology (Botany, Zoology)/ Bio Technology and further that he/she has passed the earlier qualifying examination with the following subjects- Physics, Chemistry, Biology/ Bio Technology and English.

or

(vi) Any other examination which, in scope and standard is found to be equivalent to the intermediate science examination of an Indian University/Board, taking Physics, Chemistry and Biology/ Bio Technology including practical test in each of these subjects and English.

(vii) Must have passed in subjects of Physics, Chemistry, Biology/Bio Technology & English individually and must have obtained minimum 50% marks taken together in Physics, Chemistry, Biology/ Bio Technology at the qualifying examination and must have passing marks in English.

(viii) Furthermore, study of Biology/ Bio Technology as an additional subject at 10+2 level also shall not be eligible for admission. Candidates who have passed 10+2 from Open schools or as a private candidate are also not eligible.

(ix) The candidate should be medically fit.

**Minimum Aggregate. He/She must have passed in the subjects individually and must have obtained a minimum of 50% marks in Physics, Chemistry and Biology taken together as one and in the same sitting. Compartmental Pass candidates are not eligible for admission.**

**Ensuring Eligibility. Ensuring that a candidate fulfills all conditions/ qualifications for eligibility in the BDS Course is the responsibility of the candidate. The eligibility of the candidate will be verified by the ACDS and KNRUHS at the time of admission and also later during scrutiny of papers by the University. If a candidate is found to be ineligible at any stage during the entire process, the college reserves the right to cancel his/her candidature.**

After the date of Registration is over, KNR UHS notifies the merit list as per NEET rank for those who have successfully registered online in KNRUHS website. Dates for counselling and certificate verification will be also announced by KNR UHS in their website generally around mid Aug 2024. Most probably this year the counselling and checking of documents will be online. Therefore, it is very important for all those who are registering with KNR UHS for admission in ACDS, to forward scanned copies of their eligibility documents to ACDS immediately for verification from their issuing authority.

Candidates who attend counselling are selected for BDS course 2024 by KNR UHS Selection Board and will be issued Provisional Admission Order along with the date of admission.

Provisionally selected candidates are required to submit the following in original and 08 sets of photocopies at the time of joining the college.

- (a) Proof of registration with KNR UHS (Management Quota B Category)
- (b) Provisional allotment letter issued by KNRUHS.
- (c) Hall ticket and Rank/Merit card of UG NEET-2024
- (d) Proof of age as it appears in the mark sheet of SSC/Class 10/ equivalent examination.
- (e) Certificate of passing the (10+2) CBSE/equivalent qualifying examination.
- (f) Mark sheet of passing the (10+2) CBSE/equivalent qualifying examination.
- (g) School / Institute leaving certificate (after qualifying in 10+2 equivalent examination) (Transfer certificate).
- (h) Study and bonafide certificate from 6<sup>th</sup> to 12<sup>th</sup> class.
- (i) Character and Conduct certificate.
- (j) Proof of eligible category (Certificate as applicable from 1 to 4) of ACDS BDS Prospectus - 2024.
- (k) PPO In original (for verification only) and Xerox to submit.
- (l) Migration Certificate.
- (m) Photograph – Stamp Size – 08, Passport Size –08.
- (n) Medical Certificate in prescribed format at the time of counseling
- (o) Gap affidavit as per Appx`A`
- (p) Undertaking by parent and student as per Certificate 5 & ^ of Prospectus.
- (q) Dependency certificate (Certificate 1)
- (r) Undertaking by parent and student for BDS course as per Appx`B`
- (s) Undertaking by parent and student as per Appx`B` & `C`
- (t) 20 Lakh Bond as per KNR University Prospectus.
- (u) Affidavit for original certificates are genuine as per KNR UHS Prospectus.

**Provisional Admission.** All admissions made by ACDS are provisional. An admission will be considered final only when the eligibility criteria are met and the admission of the candidate to the course is confirmed by the University. The rules and regulations of Kaloji Narayana Rao University of Health Sciences, Warangal (Telangana) shall apply to all admission procedures.

## **FEES AND REFUNDS**

### **FEES**

The fees indicated below is for the first year only. The college being a private, unaided, non-minority institution shall be entitled to vary the fees from time to time and year to year, and the fee structure from year to year shall be binding on students seeking admission to the first year of four years BDS course and one year Compulsory Rotatory Internship:-

### **Mode of Payment**

(a) **Option I** : Complete payment of **Rs 5,05,000/-** as onetime payment. Payments must be made through following demand drafts and must be produced at the time of KNR UHS counselling for admission into ACDS:-

(i) Tuition Fee and Allied charges incl Refundable Security deposit (**Rs 4,65,000/-**) Demand Draft (DD ) for Rs 4,65,000/- to be prepared in favour of Army College of Dental Sciences (Main A/c) payable at SECUNDERABAD or HYDERABAD or can be paid through Net Banking/NEFT/RTGS at the time of admission also.

(ii) Hostel Fee Rs 40,000/- Demand Draft (DD) for Rs 40,000/- to be prepared in favour of Army College of Dental Sciences (Hostel/Mess A/c) payable at SECUNDERABAD or HYDERABAD or can be paid through Net Banking/NEFT/RTGS at the time of admission also.

(b) **Option II** : **In Two Installments**

(i) **First installment (at the time of counselling)**

(aa) Tuition Fee and Allied charges incl Refundable Security deposit. Demand Draft (DD) for Rs **3,65,000/-** to be prepared in favour of Army College of Dental Sciences (Main A/c) payable at SECUNDERABAD or HYDERABAD or can be paid through Net Banking /NEFT/RTGS at the time of admission also.

(ab) Hostel fee Demand Draft (DD) for Rs **40,000/-** to be prepared in favour of Army College of Dental Sciences (Hostel/Mess A/c) payable at SECUNDERABAD or HYDERABAD or can be paid through Net Banking/NEFT/RTGS at the time of admission also.

(ii) Second Installment (within 02 months from the date of admission) : Rs 1,00,000/-  
(Demand draft to be prepared in favour of Army College of Dental Sciences (Main A/c).

(c) In addition to the above, fee for the following charges have to be paid by the students on yearly basis:-

(i) **Mess Charges.** The students Mess is run by a Mess Committee formed by students amongst themselves. Monthly messing is Rs 4200/- (Rs 140/- per day) or actual as worked out by the Mess Committee. Payment for one year (Rs 50,400/-) has to be made in advance at the time of admission as well as every year.

(ii) **Gymnasium.** Gymnasium has been installed in the college campus for students. Gym charges for Rs 600/- (i.e. Rs 50/- per month) is charged for its maint. The same will be paid in advance separately at the time of admission as well as every year.

(iii) **AWES Insurance.** All students studying in AWES Colleges have been insured centrally by HQ AWES. The AWES Insurance premium for Rs 130/- per year required to be paid in advance by the candidate every year.

(iv) University Fee is required to be paid to KNR UHS at the time counselling, if the candidate selected for allotment of Provisional Admission order. University fee amount and mode of payment will be available in KNR UHS website. Hence, candidate has to prepare separate demand draft as specified in KNR UHS website.

### **LEGAL JURISDICTION**

Any dispute regarding the terms and conditions of the admission, sale of prospectus, conduct of admission, course, fees, examination, promotion, pass marks, valuation of papers etc., concerning the Army College of Dental Sciences, Secunderabad shall be subject to the jurisdiction of the courts situated at Medchal-Malkajgiri District, Telangana only.

### **ARBITRATION**

Any dispute concerning the interpretation of any of the terms and conditions of admission and any of the paragraphs of this prospectus or any dispute concerning the sale of prospectus, conduct of admission, course, fees, examination, attendance, pass marks, valuation of papers etc., shall be resolved amicably. If the student or any parent representing any minor student and the college fails to resolve the dispute amicably, the matter should be referred to the sole Arbitration of the Chairman or any other person(s) nominated by the Chairman.

The award passed by the sole Arbitrator shall be binding on both parties. The place of arbitration shall be at Secunderabad or the college premises only and the provisions of Arbitration and Conciliation Act, 1996 shall apply to the arbitration proceedings. The courts situated at Secunderabad and Medchal-Malkajgiri District alone shall have the jurisdiction to entertain any application or litigation concerning the arbitration.

### **AN APPEAL**

Any student aggrieved by any order or orders passed by any authority or authorities of Army College of Dental Sciences shall be entitled to prefer an appeal before the Managing Committee represented by the Member Secretary and Registrar within a period of 30 days from the date of any such order and the Member Secretary shall place the appeal before the Managing Committee for passing appropriate orders. The Managing Committee presided over by the Chairman may provide the right of hearing to the student or the parent and pass appropriate orders in the form of resolution and communicate the decision of the Managing Committee/ Appellate Authority. Unless and until the remedy of appeal is availed by the student/parent, the arbitration clause cannot be invoked. The Appellate Authority or Managing Committee shall have the jurisdiction to entertain appeal concerning any grievance of the student connected with payment of fees, disciplinary action taken by the college, punishment imposed in case of malpractice or any act of misconduct, attendance, pass marks, valuation of papers etc. Wherever the matter concerns the interpretation of rules, regulations, ordinances of Kaloji Narayana Rao University of Health Sciences, Warangal (Telangana), Universities Act, 1991 the Managing Committee/Appellate Authority shall have the right to direct the student(s)/parent(s) to Kaloji Narayana Rao University of Health Sciences, Warangal (Telangana) or any other authority or authorities for the relief prayed for. The Appellate shall not pass any order or orders concerning any matters covered by the rules, regulations, ordinances, etc., to be interpreted by the University of Health Sciences.
